For what purposes will we use your personal data?

Personal data that we collect from you will be used for the following purposes that are necessary to provide the services that you request:

Which kind of personal data will we use for these purposes?

To carry out the purposes described in this privacy policy, we will use the following personal data:

- Name
- Registro Federal de Contribuyentes(RFC)
- Clave única de Registro de Población (CURP)

- Address
- Home phone number
- Cell phone number
- E-mail
- Credit card numbers

How can you access, rectify, cancel or object to the use of your personal data?

You have the right to know what personal data we collect from you, for what purposes it is used, and the conditions of use we give them (Access). It is also your right to request the correction of your personal information if it is outdated, inaccurate or incomplete (Rectification); to have us remove it from our records or databases when you believe that it is not being used properly (Cancellation); as well as to object to the use of your personal data for specific purposes (Opposition). These rights are known as ARCO rights.
